I understand that serious accidents occasionally occur during such activity and agree to assume the risk including the possibility of serious personal injury or death associated with such participation and to release and hold harmless all of the persons or entities mentioned above even though that liability arising out of or connected in any way with my participation in such activity. It is further agreed that this waiver, release and assumption of risk is to be binding on my guests, heirs, and assigns and is intended to release those persons or entities from and against any and all liability arising out of or connected in any way with my participation in such activity. If any participant is a minor, I also give my permission for his/her participation in the stated activity & for any necessary emergency medical treatment. I, the undersigned parent/guardian of this applicant, a minor, hereby release and discharge CampCo, its owners, employees, directors, officers, agents, and volunteers, from any and all claims for personal injuries as stated above. ### **Participant Cancellation Policy/Late Pick-up Policy**

For the purposes of this Cancellation Policy, CampCo defines "activity" as any class, camp or other program that CampCo offers, and that each "activity" has its own individual activity number. I understand and agree to the following Cancellation Policy.

Number of Days that notice is given to CampCo, prior to Start-time of Activity	CampCo's Policy
Seven or more (7+) calendar days	100% Refund or Transfer, less a \$5 fee per activity
Seventy-two (72) hours to six (6) calendar days	100% Credit or Transfer, less a \$5 fee per activity
Anytime prior to the start of the activity, with a Doctor's Note	100% Credit or Transfer, less a \$5 fee per activity

Credits are valid for future CampCo activities and are valid for at least one year from the date of the cancelled activities. No refunds or credits for no shows or after activity has begun nor for a partial session of a multi-day activity. A 100% refund will be given for any activities cancelled by CampCo. There are minimum and maximum participants permitted in each activity; activities may be cancelled due to low registration and no more registrations will be accepted when maximum has been reached.

Children must be picked up on time. Parents are reminded that they will be charged \$1 per minute, per child for children picked more than 10 minutes late.

**MEMBER/GUEST AGREEMENT AND RELEASE OF LIABILITY FOR CAMP PARTICIPATION**

I, \_\_\_\_\_, the undersigned **member** \_\_\_ **guest** \_\_\_ of the Lake Mission Viejo Association (“LMVA”) have requested the opportunity to participate in certain camp activities on LMVA premises (“Camp Activities”) to be provided and supervised by CampCo Day Camps.

The term “Member” as used in this Agreement includes participating Member, Member’s parent or guardian (where Member is a minor), and Member’s guests, assignees, heirs, agents, or other representatives. Participating Member/Guest **is a minor \_\_\_ is not a minor \_\_\_**. If participating Member/Guest is a minor, I \_\_\_\_\_ **the parent or guardian of said minor**, has express permission to participate in Camp Activities, and that I, as the Member’s/Guest’s parent or guardian shall be bound by the terms of this Agreement.

Participating camper and parent/guardian agree to become familiar with and abide by all rules and regulations established by CampCo Day Camps or LMVA at any time.

Member understands that in participating in Camp Activities, there are inherent risks over which LMVA may not have any degree of control. Member/Guest acknowledges the risks inherent in Camp Activities and agrees that Member/Guest is voluntarily participating in Camp Activities with knowledge of such risks. Member assumes responsibility for all risks relating to Member’s/Guest’s participation in Camp Activities, including without limitation, bodily or other personal injury or death, and damage to or destruction of Member’s/Guest’s property.

As consideration for the opportunity to participate in Camp Activities, Member/Guest releases LMVA from all liability of any kind related to Member’s/Guest’s participation in Camp Activities. Member agrees that no complaint, claim, charge, suit, administrative action, arbitration, or other legal proceeding shall be brought by Member/Guest against LMVA relating to Member’s/Guest’s participation in Camp Activities. Member/Guest agrees to defend and indemnify LMVA for any and all claims, causes of action, damages, judgments, costs, or expenses, including attorneys’ fees, which relate in any way to Member’s/Guests’ participation in Camp Activities.

Member/Guest agrees that any dispute relating to this Agreement between Member/Guest and LMVA shall be submitted to binding arbitration before the American Arbitration Association (“AAA”) of Los Angeles County, California, before an experienced arbitrator selected under the applicable rules and procedures of AAA, as the exclusive remedy for such dispute. Judgment on any award rendered by such arbitrator shall be final and binding. The fees and costs of the arbitrator and the arbitration shall be shared equally between LMVA and Member/Guest, with each party to be responsible for its own attorneys’ fees and costs.

This Agreement sets forth the entire agreement between Member/Guest and LMVA on the provisions set forth herein and supersedes all prior agreements or understandings, written or oral, between LMVA and Member/Guest. Should any provision of this Agreement and Release be determined to be illegal, invalid, or unenforceable, all remaining parts shall remain in full force and effect. This Agreement shall be interpreted under the laws of the State of California.

Member/Guest agrees that Member/Guest has carefully read and fully understands this Agreement. Member understands that this Agreement is a binding contract between LMVA and Member/Guest, which releases and indemnifies LMVA from any and all liability of any kind relating to Member’s/Guest’s participation in Camp Activities. Member/Guest agrees that Member/Guest has had the opportunity to consult with independent counsel if desired, and voluntarily executes this Agreement under Member’s/Guest’s free will.
